### **CONDITIONS OF ENTRY**

- Location: Morphett Vale Riding Club Grounds, CNR WHEATSHEAF & PANALATINGA ROADS, MORPHETT VALE SA 5162
- Unofficial Competition Open to all riders
- Morphett Vale Riding Club will not be liable or held responsible for any loss, damage or injury to horse, person, vehicle or equipment whilst on the grounds.
- Approved Current Australian Standard Riding Helmet and Riding Boots must be worn whilst mounted.
- Age of competitors are as on the day of the competition.
- The MVRC Committee reserves the right to alter or cancel any event or combine any event at its discretion.
- The judge's decision is final. Anyone displaying unsportsmanlike behaviour will be asked to leave the grounds.
- All protests must be lodged within 15 minutes of completion of the event together with a \$50.00 protest fee. If the protest is upheld the \$50.00 fee will be refunded. The committee's decision will be final.
- All tests are current EA tests, available from <a href="http://www.equestrian.org.au/Dressage-rules">http://www.equestrian.org.au/Dressage-rules</a>
- Tests may be called.
- Any horse may compete in two consecutive levels only, maximum of three tests can be ridden.
- Horses are only permitted to be tied to floats that are attached to vehicles.
- Only horses competing are permitted to be on the grounds.
- Stallions not permitted.
- Dogs not permitted.
- Entries close: Monday 30<sup>th</sup> October 2023.
- All riders who are not a MVRC member must complete a waiver, and pay day membership.
- Entries will not be accepted unless they are accompanied by a completed and signed waiver form.

- In the case of MVRC cancelling the event refunds will be given, minus a \$5 admin fee.

- Long boots, chaps or gaiters are permitted to be worn by all riders.



#### Horse Sports are a Dangerous Activity

In consideration for being permitted to participate in any way in horse sport activities and in

Particular this event,

I, \_\_\_\_\_(PARTICIPANT'S NAME), the undersigned, understand, acknowledge and accept that:

- 1. Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.
- 2. There is a significant risk that serious **INJURY** or **DEATH** may result from horse sport activities and in particular this event.
- 3. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the proprietors of (hereafter referred to as the "Releasees") or others and I voluntarily **PARTICIPATE** at my **OWN RISK** and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.
- 4. I understand and acknowledge the dangers associated with the consumption of alcohol or any mindaltering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree not to drink alcohol or take drugs prohibited by law before or during this event.



- 5. I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the <u>CANCELLATION</u> of my participation in the event and my immediate removal from my horse <u>NO MATTER</u> where that may occur. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify the Releases against all claims made by any person as a result of my failure to comply.
- 6. I agree to wear a **Current Safety Standard Helmet and Riding Boots** while riding during the event. I agree that I am solely responsible for ensuring that I wear a current standard helmet and riding boots at all times and take sole responsibility for my actions.
- 7. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS AND AGREE NOT TO SUE the proprietors of <u>MORPHETT VALE</u> <u>RIDING CLUB</u>, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, OR loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
